Note: The title takeover fee shall be deducted from the total product value.

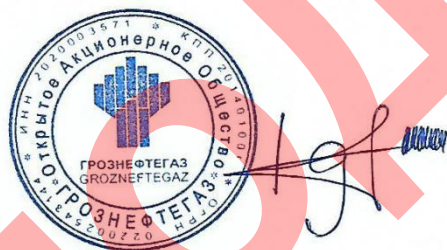
